POND UPDATE

As many of you know, we have been suffering from an accumulation of floating algae in our ponds (especially in the summer months) for the past few years. In an effort to better manage this and other pond challenges, Huntington Trails retained a new pond management company (Gulf Coast Lakes and Wetlands, or GCLW) in April 2018 and they have been treating and maintaining our ponds since then.

GCLW suggests the following preventative measures to our homeowners and lawn maintenance companies to help keep our ponds in good shape year round:

1. **Establish a NO Fertilizer buffer 15 feet off your pond banks**

When washed by sprinklers and rain down the bank slope and into a pond, fertilizers will load the ponds' water with nutrients. This nutrient loading increases the odds that a pond will be overtaken by weeds and/or have an algal bloom. Then the subsequent treatment and decay of these weeds re-releases the nutrients into the water again creating more algae blooms.

2. **Aim Grass Clippings away from your ponds**

Please direct lawn mower (and trimmer) exit chutes away from ponds when cutting grass near pond banks. When allowed to land on the pond surface, grass clippings will decay and release nutrients into the pond setting off the same processes as the loading of fertilizer.



3. **Keep Landscap Debris away from storm drains & ponds**

Landscape debris such as grass clippings, palm fronds, fallen leaves, etc will all add nutrients to the ponds if they are allowed to enter the storm sewer system or ponds. Even homeowners that do not live on the ponds should be mindful of this. Any landscape debris that goes into the road and enters the storm drains eventually reaches the ponds. Landscape debris should be collected and disposed of properly. (Homeowners may use City of Safety Harbor's yard waste recycling and mulching service including curbside pickup.)

4. **Trim Overhanging Trees**

Trees that overhang the ponds or roads should be trimmed back to prevent leaves, branches, and pollen from falling into the ponds or entering the storm drains. Fallen leaves release nutrients as they decay that feed algae and lead to muck accumulation in the ponds. Trees that overhang ponds directly are large contributors to the eutrophication process that leads to excessive growth of weeds and algae.

2018 Huntington Trails Improvements

The Street lights have been replaced within Huntington Trails in 2018. The new street lights are LED'S. The biggest change is the old lights had a yellow cast to them (good for Halloween) and the new lights are white in color. The old yellow High Pressure sodium lights burned out fairly frequently. The new lights have a life expectancy of over 20 years.

Our Home Owners Association Annual meeting will be 6:00 PM November 14, 2018 at the Safety Harbor Community Center located at 650 9th Ave S. Our meeting will be held in the Art Room. At this meeting the Association will approve a budget for 2019, elect a Board of Directors, select Officers for 2019 and discuss any neighborhood issues.

All are welcome and encouraged to attend. State law requires that at least 40 homes in our subdivision be represented at the meeting. Very rarely does this number of people attend. State law provides that homeowners can be represented by proxy. When you get your notice of the meeting from our Management Company (Ameri-tech), please return the proxy even if you plan to attend. When you get to the meeting the proxy is returned to you and you can vote in person. Each year Board Directors contact home owners to remind them of the meeting and sign a proxy. This is how we meet the state required meeting representation. The Board members will also answer any of your questions.

The Board of Directors recommended Budget for 2019 will have the same \$150 quarterly Association fee as 2018. Our Association is fortunate to have a fully funded Reserve Fund for all capital infrastructure needs.
